Other Trading Hours (OTH)	All times that are not RTH, including all hours on weekends and holidays	All times that are not RTH except for 4:30 PM to 5:00 PM ET on business days ¹ All hours on weekends and holidays	

¹ 4:30 to 5:00 PM ET on business days is considered an invalid execution time for Eris Flexes

Key Points

- 1. Both Electronic (Eris SwapBook) and Voice Trading (Eris BlockBox) are available during RTH
- Voice Trading (Blocks, EFRs and EFPs) is available during OTH
- 3. Eris Standards are available for trading 24 hours a day, 365 days a year
- 4. Eris Flexes are available for trading 23 ½ hours on valid business days and 24 hours on all weekends and holidays
- 5. All hours on weekends and holidays are considered OTH
- 6. On early closes, the OTH trading session begins immediately following the close
- 7. Eris BlockBox will open at 6:45 AM ET for reporting and submission on valid business days

Block Trading Thresholds

- Voice trading without leg risk for any size for packages including OTC or cash products
- Blocks are measured as the sum of the notional amount of all legs of a trade
- Block sizes decrease during Other Trading Hours (OTH)
