Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, (the "Act") and Commission Regulations 40.6(a), Eris Exchange, LLC ("Eris Exchange" or the "Exchange") hereby notifies the Commodity Futures Trading Commission (the "Commission") of temporary changes to the trading hours for all Eris Exchange Interest Rate Swap Futures Contracts (the "Contracts") for October 29, 2012 and October 30, 2012. The Exchange shortened the trading hours on October 29, 2012 and closed the Exchange at 12:00 pm ET. The Exchange was closed for trading on October 30, 2012. The Exchange previously notified the Commission of these changes on October 29, 2012, but is refiling these materials. The decision to change the trading hours for the Contracts was made pursuant to Exchange Rule 212 due to Hurricane Sandy.

The Exchange certifies that the temporary changes to the trading hours comply with the requirements of the Act and the Commission's Regulations.
